



## **Summary Report SICI Workshop**

## **Title of Workshop**

The impact of inspection on school improvement, the quality of teaching and the performance of children

17 – 18 September 2018

Hallmark Hotel, Glasgow

#### What was the aim of the workshop and to what extent has it been achieved?

The aim of this workshop was to discuss, analyse and reflect on the impact of inspection on school improvement, the quality of teaching and the performance of children.

This aim was achieved very well, due to the thoughtful and well-prepared contributions from colleagues and the ongoing dialogue between participants throughout the workshop. During and after the workshop, social media was used to share and discuss key messages further.

#### What lessons have we learned as a result of this workshop?

As a result of this workshop, many lessons have been learned by delegates. These include delegates recognising:

- the continued benefits of inspection and review processes in supporting and ensuring school improvement;
- the importance of ongoing partnership working between inspectors / reviewers, authority heads and practising education professionals in order to develop and support systems effectively;
- the need for inspectorates / review systems to discuss findings with a range of individuals so the inspection process is not dependent on only a few individuals to implement outcomes identified;
- the benefit of inspectorates / review systems engaging in dialogue and challenging one another constructively; and
- the continued importance of the professionalism of inspectors and the rigour and clarity of processes.

## The following contributions to the workshop were the most interesting:

Education Scotland staff ensured the workshop was very varied, with representation from a wide variety of national and international contributors.

Feedback from participants highlighted that, in particular, they enjoyed the contributions from local authority representatives - directors, service managers and headteachers. They commented that these sessions helped them to develop a broader understanding of Scotland's context.

Participants also appreciated the contribution to the workshop from colleagues from Malta, The Netherlands and Ireland. It was very interesting to hear about the impact of inspection or review in these countries. It stimulated much discussion afterwards.

All participants spoke highly of the excellent music contributions. These enhanced the workshop, as well as the networking dinner which we enjoyed on the Monday evening. The musicians came from a range of schools, including specialist music and dance schools and a community learning and development centre.

## The following activity forms were very successful:

Scottish representatives found it very useful to schedule collaborative sessions on the Monday afternoon. This enabled participants from different countries to come together to discuss common themes. The sessions were facilitated by inspectors from Education Scotland. The inspectors collated and synthesised feedback from the different groups and reported back to everyone on the Tuesday morning. This ensured coherence between the workshop sessions on Monday and Tuesday.

Most delegates also spoke very positively about the roundtable sessions. They valued being able to ask questions of panel members. These included colleagues from inspectorates / review systems internationally, as well as local authority representatives from across Scotland - headteachers and directors of education / service managers.

As always, participants enjoyed having time to engage in dialogue, formally and informally, with peers from systems across the world.

#### What would be a good follow-up theme or activity?

The final session of our workshop enabled participants to reflect on and discuss the role of SICI and inspectorates moving forwards. Specifically, this was in relation to them ensuring that inspection continues to have a significant and positive impact on school improvement, the quality of teaching and the performance of children.

A few points noted below highlight some of the themes which were discussed. Further consideration of these may lead to the design of good follow-up activities.

- Using peer inspectors and associate assessors
- Maintaining independence and speaking 'without fear or favour'
- Ensuring transparency of methodology, reports and so on
- Sharing and communicating messages accurately and timeously
- Reviewing the quality indicators regularly to ensure they continue to be fit for purpose
- Continuing to have discussions regarding the role and use of evaluation grades
- Up-skilling inspectors as necessary
- Exploring the 'make-up' of inspection teams, for example using statisticians, professionals with finance backgrounds and so on
- Encouraging inspectorates to work together more closely, sharing frameworks / aspects of frameworks
- Co-creating more activities / schedules with stakeholders

Some discussion took place between inspectors regarding the name of SICI. A few participants suggested the following title might be more appropriate - International Network of Inspectorates and Quality Assurance.
