# Inspection approaches to civic values and skills

# Scotland – inspection approach

Scotland's Curriculum 'Curriculum for Excellence' – at its centre are four capacities which reflect and recognise the lifelong nature of education and learning.

Education Scotland HM Inspectors aim to serve three main purposes:

• Public accountability, promote improvement and inform the development of educational policy and practice.

CVS – an embedded approach - not inspected as a seperate area

## Sweden – inspection approach

- CVS is not inspected as a seperate field several elements of CVS (eg. gender equality and democracy issues) are inspected
- Main two branches of inspection are legal inspections (focusing on compliance with the law) and quality audits (focusing on quality aspects)
- The inspectorate can inspect elements of CVS on school owner level and school unit level
- The inspectorate has conducted thematic inspections on different themes of CVS
- Sweden has a national curriculum several aspects of CVS are incorporated in the national curriculum
- Main principle: schools are obliged by law to provide education based on the national curriculum, students are obliged by law to attend school and participate in education
- The inspectorate can inspect: whether schools adhere to the national curriculum whether schools follow up on students who fail to attend school
- The inspectorate has a focus on extremism, radicalization and anti-democratic elements when anti-democratic elements are found among school owners, the inspectorate can
  impose sanctions and, in the event of serious misconduct, close schools

## The Netherlands – inspection approach

- *Legislation?* New legislation from 1st of August 2021. Essential elements of CVS education: active citizenship & social cohesion > purposeful, targeted & coherent
- What and how to teach CVS? What is defined in the law & core national objectives, how to teach is what schools are free to decide
- How do we inspect? Inspection framework governing board and schools & thematic inspections – schools
- How do we report? System level (e.g. Annual State of Education report & thematic reports), governing board & school level
- How do we follow up? Remedial action orders & further engagement
- *Challenges?* Monitoring CVS, role & responsibility of inspectorate, sensitive & controversial topic in politics & society

# Project findings

#### Different definitions CVS

The Netherlands  $\rightarrow$  focus on active citizenship & social cohesion. CVS is part of the inspection framework; it needs to be implemented in education in a targeted and coherent manner.


Sweden  $\rightarrow$  focus on democratic values and norms.

Elements of CVS are inspected during legal inspections and quality audits.

Scotland  $\rightarrow$  not using a single definition; holistic approach.

CVS is not an individual area of inspection, several indicators are related to this, these are evaluated from a holistic perspective.

## Take aways: inspiration

- All encompassing approach by Scottish inspectorate (child-centred) > wider range of education settings
- Using expert analyses to inform inspections in Sweden and the Netherlands.
- Developed new legislation on CVS in the Netherlands outlining what is expected from schools.
- Legal inspections and quality audits on CVS elements in Sweden.
- Schools visited in all 3 countries were good examples of incorporating CVS education.
- Use of self evaluations for schools and associate assessors during inspections in Scotland.
- Inspection on governing board level the governing boards need to ensure adequate quality on CVS education

#### Take aways: dilemmas

- Dilemma between autonomy of schools and regulations by the government
- Dilemma on monitoring CVS results and outcomes in schools
- Differences in depth of focus on CVS during inspections
- Dilemma on the role of inspectorate (tension between policy, development & supervision)
- Recognize that we could do more to share highly effective examples of how to work on CVS education.
- To truly see the impact of CVS curriculum, schools and inspectorates need to look at the wider impact in society.

## How to drive improvement in CVS?

#### Policy makers:

Creating/adjusting the law concerning CVS education

#### Inspectorates:

- Sharing good examples between schools and wider education settings
- Discuss potential personal biases of inspectors
- Focus on education experiences in wider educational settings such as community
- Recognise achievements and accreditation of CVS

#### Schools/educational settings:

- Active student/learner participation
- Acknowledge and value of out-of-school experiences
- Linking school and the wider society recognising the totality of the learning environment
- Diversity of teachers/educators and students contributors to the development of CVS
- A targeted and coherent manner of offering education in CVS
