Governance and Strategic Direction

Reviewing our statutes

The Executive Committee held a focused working session recently to review our statutes and prepare the next steps in SICI's governance modernisation. This marks the early stage of a wider, carefully sequenced process to ensure our statutes remain fit for purpose.

At this point, this is simply to let members know about the review. A dedicated communication will follow shortly, setting out the full timeline, the consultation process, and how each member organisation will be invited to engage with the draft statutes before they are put to a vote.

Strategic Plan 2026–2030 Published

Our new Strategic Plan has now been published. It sets out SICI's priorities for the coming years and provides a clear framework for strengthening our collective work. Members can access the full document on the website.

The new Strategic Plan, 2026–2030, presented to the General Assembly 2025, is the outcome of a full revision process involving member feedback, with several adjustments made based on contributions from across the network.

The plan will carry forward the spirit of collaboration, professional growth, and international engagement that has defined our work to date. It also invites us to think boldly about the future.

The Strategic Plan 2026–2030 was approved unanimously by all SICI members at the General Assembly.

External Engagement – ERI SEE Regional QA Cooperation Meeting

In December, I was invited to contribute to the *Future Directions and Planning of Regional QA Cooperation* meeting organised by the Education Reform Initiative of South Eastern Europe (ERI SEE). The event brought together colleagues from across the region, alongside representatives from the European Training Foundation (ETF), to explore emerging developments in quality assurance and opportunities for deeper regional collaboration.

I presented on contemporary developments and challenges in quality assurance for general education, offering insights from SICI's work and the wider European landscape. This engagement strengthens SICI's relationships with regional partners and reinforces our shared commitment to improving inspection, evaluation, and quality assurance.
