Next SICI Workshop in Tartu, Estonia "Inspection and school autonomy: Benefits and challenges in a changing world"

We are very much looking forward to seeing our members at the next workshop in Tartu, Estonia, on **13th and 14th of June 2024**, where we will continue our important conversations with a focus on "Inspection and School Autonomy: Benefits and Challenges in a Changing World."

The aim of this workshop is to explore the evolution and impact of inspection systems within educational environments that recognise school autonomy in diverse ways. Participants will have the opportunity to hear about and discuss the experiences of several



countries, including our hosts, where schools enjoy extensive autonomy, allowing them to shape their educational environments independently. This workshop will facilitate reflection on key learnings from various inspectorates and how these insights might be applied to different inspection contexts. Additionally, we will delve into Estonia's success in the Programme for International Student Assessment (PISA). We look forward to your active participation in these enriching discussions.

SICI project "Supervision of education related to the development of civic values and skills".

We are delighted to share the inspiring collaboration between the Swedish, Scottish, and Dutch inspectorates on our recent project focused on the supervision of education related to Civic Values and Skills (CVS). This initiative exemplifies our commitment to promoting and supporting partnership and cooperation between inspectorates.

Civic Values and Skills are essential for individuals to engage positively in society and uphold democratic values. These skills, including social and emotional competencies, are fundamental to the socialization process in education. Given the current climate of political polarisation and the pressures on democratic values, the relevance of CVS has never been more critical.

The project aimed to explore how various inspection processes can provide insights into the impact of education on CVS. Our members also investigated how inspectorates can use these insights to drive improvements. By clarifying the tools used to assess CVS and exchanging best practices through case studies and work experiences, they have gathered valuable information that can benefit all our member organizations.

The project activities, which included job shadowing, roundtable discussions, and a seminar, were made possible through SICI's funding. This collaborative effort has culminated in a comprehensive final report, highlighting key findings and recommendations. Here are a few key messages from the report:

- **Integrated Approaches:** Effective supervision of CVS requires integrated approaches that combine both qualitative and quantitative assessment tools.
- **Collaborative Learning:** Sharing best practices and experiences through job shadowing and discussions enhances the capacity of inspectorates to address CVS in diverse educational contexts.
- **Continuous Improvement:** Ongoing dialogue and cooperation among inspectorates are vital for continuous improvement in the supervision and development of CVS.

Our thanks to the Swedish, Scottish, and Dutch inspectorates for their dedication and collaboration. Their commitment has made this project a success, providing valuable insights and strengthening our collective efforts.

The final report is now available to all SICI members on our website, and we would encourage you to review it and consider how its findings might support your work.

Together, let us continue to foster strong partnerships and cooperation, ensuring that our educational systems support the development of civic values and skills for a better future.

STESSIE :TRAINING ACTIVITY DONOSTIA-SAN SEBASTIÁN 11-15 MARCH 2024

From March 11th to 15th the 3rd Training Activity of STESSIE took place in Donostia-San Sebastián, Basque Country. The objectives of the week were: to know about the specific characteristics of the Community of Madrid, the Valencian Community and the Basque Country in relation to social inclusion policies; to evaluate and propose improvements to TESSIE 2.0.; to listen to experts on the matter; to visit schools and exchange experiences

related to inclusion; to apply the TESSIE 2.0 tool and analyse results in several schools; and to disseminate the project and its results to other institutions. We had the chance of listening to Andrea Hathazy (PHD. Special Education Department Faculty of Psychology and Educational Sciences in Babeş-Bolyai University Romania, From policies to best practices in inclusive education), to Dr. Thomas Michels (President of a regional inclusion-commission in Luxembourg, Inclusion programs in Luxembourg) and to Noorani Sogol (Education Policy and Systems Analyst. European Commission-EACEA-Eurydice).

TESSIE 2.0 tool was piloted in several schools: the questionnaire has been passed on to teachers, parents and students of Primary level (11-12 y.o.) and we have used three different versions: Spanish, Catalan and Basque. The schools have given an assessment of the tool: in terminology, we received 309 answers and most people said there was no word that was hard to understand, and that the questionnaire was well understood, although some questions may be redundant, repetitive.
